Meeting called to order at 6:45, location: 10349 Blackman Road, Kingsley: Motion by Gerou, Second by Smeltzer, motion carried.

Treasurer's Report: Kelly Leonhard recapped bank account information (balance \$6676.05 as of 5/31/15). Motion by Smeltzer, Second by Gerou to accept Treasurer's report, motion carried.

Bylaws: Discussion regarding bylaws and its application to points calculation, specifically:

**Section 13)** A person must show in a NMAWHC approved or optional class at five (5) of the NMAWHC approved shows to be eligible for a year-end award in that class with the exception of Leadline.

Motion by Browe, support Forton to interpret bylaws as a person may be eligible for year-end award in a class if they participate at all in that class, motion fails.

Photographer: Megan Ryan-Kessel has suggested Jake Staley as the photographer for the Anna Bays shows. The fee would be \$100 per show weekend and lunch supplied. Copies will be available to NMAWHC for the annual banquet. Exhibitor's can buy photos directly from Staley. Motion by Smeltzer, Second by Stevens to retain Staley's photography services for both Anna Bays weekends, motion carried. Anna Bays Series Hi Point was discussed including buckles. The Hobby Horse hat raffle was discussed. Friend asked for a couple raffle tickets to use to incentivize NMAWHC's social media – fb, twitter, Instagram. Consensus to approve the use of two raffle tickets. Leonhard suggested a 'suggestion box' at the show. Discussion of using an 'order of go' we previously discussed.
